RCUB has established the institutional repository MyRepo. It is the joint digital repository of ALL MEMBERS/DEPARTMENTS of the (repo_owner) OR PARENT UoB. The aim of the repository is to provide open access to digital collections of RCUB. The main aim of this repository is to increase the visibility of its research output / OR of the MEMBERS_DEPARTMENTS of the UoB and, at the same time, provide free access, in compliance with the [Institutional] open access policy of the UoB passed by the GOVERNING_BODY (DATE OF POLICY).

The aim of this policy is to ensure that the contents of MyRepo reflect and strengthen the ! UoBRCUB's tradition of research excellence, by increasing the visibility of RCUB's research, and providing open access to RCUB research outputs. This policy also establishes the framework within which MyRepo is managed.

DESCRIPTION OF REPOSITORY PLATFORM AND VENDOR; EXAMPLE: The repository uses a DSpace-based software platform developed and maintained by the MAINTAINER/SUPPORTER. The software platform is compliant with the OpenAIRE Guidelines for Literature Repositories v3. DESCRIPTION OF FRONT-END APP SUPPORTING DEPOSITORS OR OTHER USERS, EXAMPLE: The repository is supplied with the external application FRONT-END APP, developed by the SOLUTION DEVELOPER. In FRONT-END APP, authors and funding information are presented as normalized entities. FRONT-END APP also enables metadata export and displays Altmetric scores and Dimensions citations.

Designated Community

The Designated Community of MyRepo includes the following user groups (PLEASE ADAPT): Internal users: MEMBERS/STAFF of RCUB OR PARENT UoB. They can deposit their research outputs in the repository, browse and search the metadata, and, in most cases, download content from all repository collections.

External users: local and international professional researchers, citizen scientists, teachers, students, informed citizens, the general audience, etc. They can browse and search the metadata, and download the Open Access content from the repository.

(OPTIONAL) Associates, i.e. local and international professional researchers who have joint projects with internal users. They can browse and search the metadata, download Open Access content from the repository, access the collection dedicated to their project.

Metadata Policy

- Anyone may access the metadata free of charge.

- The metadata may be re-used in any medium without prior permission for not-for-profit purposes provided:
- The OAI Identifier or a link to the original metadata record is given
- RCUB is mentioned

- RCUB is dedicated to providing high-quality and machine-readable item-level metadata.
- Mention of MyRepo is appreciated but not mandatory.

Data Policy

- Anyone may access items free of charge.
- All items are individually tagged with differing permissions and terms of use.

- All items in MyRepo should be published under an open license, preferably the Creative Commons Attribution CC BY (Attribution Only, <https://creativecommons.org/licenses/by/4.0/>) license. This is at the discretion of the author and depends on funder's requirements, and licensing requirements of input content. In some instances, CC BY-SA (Attribution + Share-alike, <https://creativecommons.org/licenses/by-sa/4.0/>), CC BY-NC (Attribution + No Commercial Use, <https://creativecommons.org/licenses/by-nc/4.0/>), or CC0 Public Domain Dedication option ("no rights reserved", <https://creativecommons.org/publicdomain/zero/1.0/>) may be more appropriate.
- The used license is explicitly indicated in item metadata.
- The license and access status and of the items will be made machine-readable per state of art conventions, guidelines and relevant and widely applied standards.

- Data can be harvested by robots for full-text indexing or analysis.
- Mention of MyRepo is appreciated but not mandatory.

- MyRepo holds all types of materials.
- Items are individually tagged with their type, date, version, peer-review status and publication status.
- MyRepo holds all types of materials.

Submission Policy

- Items may only be deposited by authorised users of MyRepo with appropriate credentials.
- Authorised users include:
 - Librarians
 - Staff members
 - Researchers
 - Associates
- The submission process must conform to submission guidelines in Document NAME (such as User manual) [EXTERNAL_LINK](#)
- Items may not be deposited until any publishers' or funders' embargo period has expired.
- The administrators vet items for the eligibility of authors/depositors, relevance to the scope of MyRepo, valid layout and format, and the exclusion of spam.
- Items can be deposited at any time, but will not be made publicly visible until any publishers' or funders' embargo period has expired.
- repo_owner
- Deposited metadata and items are subject to verification by repository administrators
- Any copyright violations are entirely the responsibility of the authors/depositors.
- If MyRepo receives proof of copyright violation, the relevant item will be removed as soon as possible.
- Files exceeding 0 in size should not be directly uploaded to the repository. For files with sizes larger than 0, a special upload permission may be sought out with repository administrators. // intentionally not offering to provide a link to an external hosting site should be used, as it breaks the purpose of the repository
- By depositing metadata and the content into MyRepo, the depositors accept the terms and conditions defined in this Repository Policy.

Preservation Policy

- RCUB will try to ensure continued readability and accessibility.
- Where possible items will be migrated to new file formats when necessary.
- It may not be possible to guarantee the readability of some unusual file formats. The repository may work with external partners to convert or migrate file formats, develop and implement software emulations for old file formats, and/or record preservation metadata. // sve ovo
- Items will be retained for at least 0 years from the date of depositing.
- MyRepo will try to ensure continued readability and accessibility of items in the repository. However, it may not be possible to guarantee the readability of some unusual file formats over time.
- Items will be migrated to new file formats where necessary.
- Where possible, software emulations will be provided to access un-migrated formats.
- It may not be possible to guarantee the readability of some less common file formats.
- MyRepo regularly backs up its files according to current best practice.
- The original bit stream is retained for all items, in addition to any upgraded formats.
- Items may not normally be removed from the repository.
- Acceptable reasons for withdrawal include:
 - Journal publishers' requirements
 - Proven copyright violation or plagiarism
 - Legal requirements and proven violations
 - National Security
 - Falsified research
- Withdrawn items remain available for audit purposes to animistrators only.
- Optional for repos without moderators!! Full-text items may be removed or replaced at the request of the author/copyright holder, but meta-data with explanatory notes about interventions must remain.
- Withdrawn items are not deleted per se, but are removed from public view.
- Withdrawn items' identifiers/URLs are retained indefinitely.
- URLs will continue to point to 'tombstone' citations, to avoid broken links and to retain item histories, with:
 - A link to a replacement version, where available
 - A note explaining the reasons for withdrawal
- The metadata of withdrawn items will not be searchable
- Changes to deposited items are not permitted.
- Errata and corrigenda lists may be included with the original record if required.
- If necessary, an updated version may be deposited.
 - The earlier version may be withdrawn from public view.
 - There will be links between earlier and later versions, with the most recent version clearly identified.
 - The original URL will be linked to the latest version.
 - The item's persistent URL will always link to the latest version.
 - In the event of MyRepo being closed down, RCUB will endeavour to transfer the database to another archive.

About Creative Commons licenses

If deposited under CC BY license, data and metadata can be:

- accessed free of charge,
- shared: copied, reproduced, displayed, performed, given to third parties, redistributed and stored in a database in any medium or format,
- adapted: remixed, transformed, and built upon for any purpose, even commercial.

Unless CC0 Public Domain Dedication option is declared, the user must provide the attribution of the original work by giving appropriate credit, providing a link to its license and indicating if changes were made.
