

Mission of NI4OS-Europe






the development and inclusion of the national Open Science Cloud (OSC) initiatives in 15 Member States and Associated Countries in the overall scheme of EOSC governance

T6.3 – Support to EOSC service uptake and FAIR uptake in communities



"NI4OS-Europe and EOSC services accompanied with the uptake of imposing FAIRness needs to be promoted throughout the user communities directly involved in the project either as thematic service providers or as users"

- First we analyse the outcome of T2.1 Stakeholder analysis & mapping on what has to do regarding EOSC and FAIR.
- Actions need to be adopted to raise awareness on such topics to the user communities of each country.

Each country has identified a national EOSC promoter by **November 2019**

- Task: to ensure demonstration of services integrated into EOSC as well as the understanding of the EOSC policies, FAIR best practices, access and usage policies.
- Need to organise training events for EOSC promoters (train the trainers)



EOSC Promoters characteristics

The EOSC promoter should have an extended knowledge on Open Science, Open Access, FAIR principles etc

- Being able to contact and provide useful support to all different stakeholder profiles – supported by the partner organizations
- A role with high visibility in the relevant country so to contact stakeholders
- Being involved in related initiatives
- Good communication skills and proven ability to communicate to small as well as to large audiences
- Participate in all train-the-trainers events which are organized by the NI4OS-Europe consortium





Challenges faced by EOSC promoters


Need to clarify between definitions

- Media ignored EOSC Promoters
 - We needed to change to a more popular tone
 - We used catchy thematic services to attract the attention
 - □ For instance Zoe's service Ingredio (<u>http://www.ingred.io/</u>)
- Covid-19 has introduced communication difficulties




- Hard to have an appearance in Scientific events. Time restrictions do not allow EOSC promoters to "intrude" into purely scientific workshops/conferences.
- It would have been much easier if events were in person (after Covid-19)
- A necessity to provide more exposure to our EOSC promoters -> Webpage






